

NOTICE OF REHABILITATION BOARD OF APPEALS MEETING

The Royal Oak Rehabilitation Board of Appeals will hold a meeting at 7:00p.m. on Wednesday, February 24, 2021.

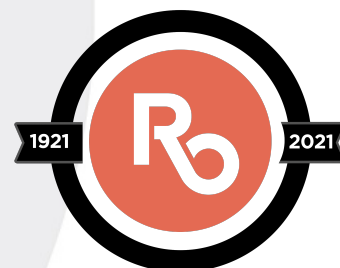
