The Royal Oak Board of Review will hold appeal hearings by appointment 9:00a.m. to noon on Monday March 8 and Tuesday, March 9, 2021 AND 6:00p.m. to 9:00p.m. on Monday, March 8 and Tuesday, March 9, 2021
