#### a. Updates from working groups

- i. Communications and Information - Janice Wagman a working group member reported on behalf of for Sharlan tonight. Royal Oak Review delivery does not cover to all of Royal Oak, working on a SWAT analysis of each of the publishing sources, revisit the statements, belief that one source can solve multiple problems for many workgroups, offering to housing group contacts for seniors who need ramps built or other repairs/improvements needed, Royal Oak Farmers Market used to host Senior Health Fair but no longer do so, wants to see more Go-Go senior vendors and not just hospice vendors.
- ii. Transportation/Paul Webb- Challenge to get the word out to seniors, lost one resident participant, last meeting did not have quorum, there is interest increasing parking and accessible spaces, more bike lanes, more hours of bus program at senior center, accessibility on website with better search, pedestrian safety, MOGO tricycles offered.
- iii. Health and Community Support Services/ Rebecca Cheezum- Grow the programming of each group, ie Henry Ford lunch and learn, Paul Webb was a guest about transportation for medical needs, fire department visited, Amanda and Saul from Henry Ford Centennial Commons building, Matthew at library for partnerships, next week someone from Demetria Friends to train on how to handle a person afflicted with, financial fraud expert to talk about how to stay safe, leaning on recommendations from all experts.
- iv. Outdoor Spaces and Buildings/Sue Wells- Content, resources available yet not everyone knows how to use or that they exist, content to things that exist and

content for education resources, might have lost one resident, process of identifying what they have learned, has Canton contacts for AARP affiliation AIG

- v. Community Engagement and Inclusion/Sarah and Jackie- Overall goal is to keep this group to the end of implementation, not a clear path for each group, keep curating communications group can help get all the learned knowledge to seniors, great tools do exist but need multiple distribution methods, Google Form sent out and 20 replied, neighborhood block parties, next meeting is tomorrow,
