### **Additional Incidents and Information**

#### **Possession of Synthetic Narcotic, Possession of Methamphetamine, Possession of Stolen Property, Driving While License Suspended, and Misdemeanor Warrant Arrest**

On January 8, 2022, at approximately 11:30 p.m., Officers conducted a traffic stop near Eleven Mile Rd and Stephenson Hwy. The license plate on the vehicle was reported stolen. The driver quickly exited the vehicle and attempted to walk away from the officers. The officers ordered him to stop, and he complied. The driver was in possession of assorted pills and methamphetamine in a plastic baggie.
